The evolving global economic and business landscape of the late 1990s prompted the government to establish an entity that would better organise and represent Singapore's business community. In July 2001, the Minister for Trade and Industry introduced a Bill in Parliament to establish the SBF Act, which was passed by the Parliament and become law on 5 October 2002. Under the SBF Act, all Singapore-registered companies with shared capital of S\$500,000 and above are members of the Singapore Business Federation (SBF). The Federation was established on 1 April 2002.
